



HIGHLIGHTS OF JANUARY - DECEMBER 2019 ACCOMPLISHMENTS

CONSTRUCTION INDUSTRY AUTHORITY OF THE PHILIPPINES (CIAP)

- The CIAP Board continued to formulate and/or implement policies, programs and measures to support the development of the industry which are necessary to come up with an overall I strategy for the industry's sustainable growth. It issued 9 Board Resolutions/policies to address critical industry issues/concerns.
- Reviewed and provided inputs on the following: a) proposed Philippine Construction Industry Development Act (PHILCIDA) Bill, b) Senate Bill No. 1907 (Amending the Investment Restrictions in Commonwealth Act No. 541), c) Senate Bill No. 2102 (Amending the Foreign Investment Act or RA 7042), and d) House Resolution No. 8867 (New Building Act)
- Policy research/study and drafted the Interim Manual of Instructions for Sheriffs/Judgment Enforcement of CIAP
- Formulated/consolidated/submitted CIAP's Citizen's Charter Handbook

PHILIPPINE CONTRACTORS ACCREDITATION BOARD (PCAB)

- In order to promote the safety and protect the interest of the general public from risks of dealing with unqualified and incompetent contractors, the CIAP through PCAB regulates the construction sector through contractor licensing & registration. PCAB also investigates and imposes sanctions against erring contractors.
- It approved 22,406 applications of all types (new licenses, renewal, license amendments & upgrading, and special licenses). Of these, 3,891 is for CFY 2018-2019 and 18,516 is for CFY 2019-2020:

- To date, there are a total of 2,281 Accredited CPEs and 103 government agencies including Local Government units with established Constructor Performance Evaluation Systems (CPES) Implementing Units.
- PDCB, conducted an Orientation on the Philippine Green Building Code and organized a Technical Working Group (TWG) for Green CPES Guidelines.
- Finalized the draft of the Philippine National Standard (PNS) of CIAP Document 102

CONSTRUCTION INDUSTRY ARBITRATION COMMISSION (CIAC)

- The CIAP through the Construction Industry Arbitration Commission (CIAC) makes available a venue to resolve claims and disputes arising from contacts entered into by parties involved in construction in the Philippines.
- A total of 54 arbitration cases with a Total Sum in Dispute (SID) of PhP 10.178 Billion were resolved / awarded on the merits within 6 months from TOR signing/approved time extension. Likewise, 9 cases were settled with a total SID of Php 541.62 Million.
- The CIAP Sheriffs served a total of 384 Notice of Garnishments. Awards for 6 cases with a total amount of Php 15.4 Million were fully satisfied and 10 cases with a total amount of Php 27.29 Million were partially satisfied

CONSTRUCTION MANPOWER DEVELOPMENT FOUNDATION (CMDF)

- The CMDF is involve in the conduct of construction manpower training & human resource development program for the construction industry. Such required the collaborative efforts industry, government & related construction organizations/associations.
- Produced 7,550 graduates from a total of 134 runs of the following programs: a)
 Construction Management Courses, b) Supervisory Development courses and c)
 Productivity Skills & Trade Testing.
- CMDF facilitated twenty-one (21) Authorized Managing Officer (AMO) Seminars with a total of 3,298 participants.
- The Construction Entrepreneurial Development Course Design/Proposal was presented & approved by PCAB to be included in the 1-Day AMO Seminar, 1st run target is 4th quarter 2019;
