SPECIAL LICENSING AND REGISTRATION FACILITY FOR  
SUBCONTRACTORS AND SPECIALTY CONTRACTORS IN  
GOVERNMENT PROJECTS

WHEREAS, there are subcontractors and specialty contractors who implement portions of the work of a prime contractor in government projects without the appropriate contractor's license;

WHEREAS, one of the Terms and Conditions for the issuance of the license is that the licensee must only employ licensed subcontractors and specialty contractors;

WHEREAS, engaging unlicensed subcontractors and specialty contractors is a violation of the Contractors' License Law;

WHEREAS, to eradicate this illegal practice the Board will provide a facility for these government contractors to have their subcontractors and specialty contractors licensed;

NOW THEREFORE, for in consideration of the foregoing premises, the Board in its effort to rid government projects of unlicensed subcontractors and specialty contractors, RESOLVES, as it is hereby RESOLVED to provide a special facility to license the aforementioned, as follows:

1. All unlicensed subcontractors and specialty contractors in all government projects are eligible to avail of this facility;
2. For the purpose of determining eligibility to apply under this facility, the applicant shall secure the endorsement of its prime contractor stating, among others, that said applicant is a subcontractor or specialty contractor for its government projects to be enumerated in the endorsement;
3. The prime contractor will be granted an amnesty for reporting its unlicensed subcontractors and/or specialty contractors in the endorsement for the duration of this facility;
4. Any classification and category may be applied for but the applicant must apply and qualify for the classification and category commensurate to the amount of contract awarded by the prime contractor.

5. All requirements for a contractor's license shall be complied with by the applicant. In addition to the corresponding license fees, an Additional License Fee (ALF) in the amount of PHP 10,000 shall be assessed for undertaking construction without a license;
6. This special facility shall be effective fifteen (15) days from publication in a newspaper of general circulation until 30 June 2016.
