RESOLUTION NO. 02 - 2018

**EXPANDING THE MEMBERSHIP OF THE COUNCIL OF ADVISERS
TO THE COMMISSION (CAC)**

WHEREAS, to speed up action on matters referred by the Commission to the Philippine Institute of Construction Arbitrators and Mediators, Inc. (PICAM) for inputs/recommendations and to provide legal advice/assistance to the Commission in the conduct of policy studies and drafting of the necessary policy resolutions, the Commission, in its 152nd Regular Meeting held on 26 April 2013, acting on the proposal of the CIAC Chairman, Atty. Manuel M. Cosico, created the Special Advisory Council to the Commission headed by the CIAC General Counsel, Atty. Alfredo F. Tadiar, and composed of the following PICAM lawyer-members:

1. Atty. Arthur P. Autea;
2. Atty. Primitivo C. Cal;
3. Atty. Roberto N. Dio; and
4. Atty. Victor P. Lazatin;

WHEREAS, in its 153rd Regular Meeting held on 27 May 2013, the Commission agreed to rename the council as "Council of Advisers to the Commission" or CAC which will work independently of the CIAC General Counsel and which will report directly to the Commission on an on-call basis to provide the Commission with different points of view, opinions, perspectives, and recommendations on matters referred for study;

WHEREAS, during the 202nd CIAC Regular Meeting held on 15 February 2018, Atty. Cosico, who tendered his resignation as CIAC Chairman effective 28 February 2018 but extended to 31 March 2018 upon the request of the Philippine Domestic Construction Board (PDCB), assured the body that he will continue to assist the Commission in any way he can and for this purpose, volunteered to be a member of the CAC; and

WHEREAS, Atty. Cosico also suggested that Engr. Ramon F. Allado be included as a member of the CAC;

NOW THEREFORE, THE COMMISSION, in light of Atty. Cosico's offer to be part of the CAC, and after due deliberations in its 204th Regular Meeting, **RESOLVES**, as it is hereby **RESOLVED**, to expand the membership of the Council of Advisers to the Commission (CAC) to include Atty. Manuel M. Cosico, former Chairman of the Commission and an accredited CIAC arbitrator, as CAC head and Engr. Ramon F. Allado, also a CIAC accredited arbitrator, as additional member.
