**APPROVING THE IMPLEMENTATION OF THE PHILIPPINE CONTRACTORS  
ACCREDITATION BOARD (PCAB) RESOLUTION NO. 079, S 2016  
INCREASING THE LICENSING AND REGISTRATION FEES  
FOR CFY 2017-2018**

**WHEREAS**, Presidential Decree PD 1746 or (Creation of CIAP) provides that CIAP shall exercise jurisdiction over the its implementing arms to include Philippine Contractors Accreditation Board (PCAB) which has the powers to issue, suspend and revoke licenses to construction contractors under R.A. 4566 (The Contractor's License Law);

**WHEREAS**, R.A. 4566 or (The Contractor's License Law), provides that the PCAB is empowered to collect fees and undertake income-generating activities necessary in the execution of its functions;

**WHEREAS**, for more than 15 years, PCAB has not adjusted the fee structure to reflect the current values;

**WHEREAS**, in its Regular Meeting held on 19 May 2016, PCAB recognized the need to adjust the fee structure based on the purchasing power of peso (derived from the inflation index), passed Resolution No. 079, s. 2016, upgrading the License and Registration fees structure effective starting Contracting Fiscal Year of 2017-2018;


**WHEREAS**, in the CIAP 72nd Regular Meeting held on 31 May 2016, the Board passed Resolution No. 07, s. 2016 confirming the imposition of a legal interest rate of six (6) percent on all licensing and registration applications effective Contracting Fiscal Year of 2017-2018 as reflected in the table of fees under PCAB Resolution No. 079, s. 2016;

**WHEREAS**, acceptance of renewal applications for CFY 2017-2018 has started as early as January, 2017, thus, the CIAP Board in its 74th Regular Meeting held on 27 March 2017 agreed to implement the imposition of the increased fees in licensing and registration thereon.

**NOW, THEREFORE**, in consideration of the foregoing premises, the CIAP in its 74th Regular Meeting held on 27 March 2017, **RESOLVES** as it is hereby **RESOLVED**, to approve the implementation of the Philippine Contractors Accreditation Board (PCAB) Resolution No. 079, s. 2016 increasing the licensing and registration fees as reflected in the Table of Fees in the said Resolution hereto attached as "Annex A" and made an integral part of hereof.

WHEREAS, it has been more 15 years since PCAB had set its fees and to keep up with the increasing cost of regulation, a corresponding increase in said fees is necessary;

WHEREAS, the legal interest rate of six percent (6%) is a fair rate to apply to determine how an amount of money will appreciate over a period of time;

NOW, THEREFORE, the Board RESOLVES as it is hereby RESOLVED to increase all licensing and registration fees effective on all applications applying the legal interest rate effective Contracting Fiscal Year 2017-2018, as follows:




