



**CIAP BOARD RESOLUTION NO. 2**  
**Series of 2017**

**REQUESTING THE REINSTATEMENT OF THE CONSTRUCTION INDUSTRY AUTHORITY OF THE PHILIPPINES AS PERMANENT MEMBER TO THE BOARD OF CONSULTANTS (BOC) OF THE NATIONAL BUILDING CODE OF THE PHILIPPINES (NBCP OR PD 1096)**

On motion duly seconded.

**WHEREAS**, the Construction Industry Authority of the Philippines is the central authority and acts as the forefront for the construction policy and program formulation, development and implementation;

**WHEREAS**, pursuant to Special Order No. 66, Series of 2007, issued by the Department of Public Works and Highways (DPWH), reconstituting the membership of the Board of Consultants (BOC) of the National Building Code of the Philippines (NBCP) tasked, among others, to study the proposed amendments to the NBCP or PD 1096, including the formulation of its Implementing Rules & Regulations (IRR), of which CIAP was one of the permanent representatives to the BOC;

**WHEREAS**, pursuant to CIAP Board Resolutions No. 10, s. 2007 and No. 1, s. 2011, the CIAP requested, among others, the inclusion of a representative from the private construction contracting sector as member of BOC;

**WHEREAS**, on 4 April 2011, DPWH Special Order No. 73, Series of 2011, revised Special Order No. 66, Series of 2007 reconstituting the membership of the Board of Consultants (BOC), of which, CIAP was no longer included in its membership while the Philippine Constructors Association, Inc. was named among its members;

**WHEREAS**, on 23 February 2016, DPWH Special Order No. 31, Series of 2016, revised Special Order No. 73, Series of 2011 reconstituting the membership of the Board of Consultants (BOC), of which, CIAP and the Philippine Constructors Association, Inc. were no longer named among its members;

**WHEREAS**, in the CIAP 73<sup>rd</sup> Regular Meeting held on 12 January 2017, the CIAP Board recognizes that the scope and application of P.D. 1096 and its IRR cover not only the design of buildings and structures but also construction, alteration, repair, conversion, demolition and other construction-related activities;

**WHEREAS**, the CIAP Board, also, recognizes that while the design and professional consulting sectors of the industry are adequately represented in the BOC, its reconstituted membership does not include the government agency that regulates the construction sector;

**NOW, THEREFORE**, the Construction Industry Authority of the Philippines, after due deliberations during its 73<sup>rd</sup> Regular Meeting held on 12 January 2017, **RESOLVES**, as it is **HEREBY RESOLVED**, to request the reinstatement of the Construction Industry Authority of the Philippines as permanent member to the BOC of the National Building Code of the Philippines.


