



**CIAP BOARD RESOLUTION NO. 09
SERIES OF 2017**

**FOR THE PHILIPPINE DOMESTIC CONSTRUCTION BOARD (PDCB) TO
INSTITUTIONALIZE THE ENFORCEMENT OF CONTRACTORS PERFORMANCE
EVALUATION SYSTEM (CPES) PROGRAM TO COVER ALL GOVERNMENT AND
PRIVATE PROJECTS**

WHEREAS, the Construction Industry Authority of the Philippines (CIAP), an attached agency of the Department of Trade and Industry (DTI), under Section 2 (a) of PD 1746 is tasked to promote, accelerate and regulate the growth and development of the construction industry in conformity with national goals;

WHEREAS, Section 6 b.2 of the same law provides that Philippine Domestic Construction Board (PDCB), one of the implementing boards of CIAP, is tasked to monitor and evaluate information on the status of public construction as well as on the performance and contracting capacity of contractors engaged in such projects.

WHEREAS, CPES is a uniform rating system for evaluating the performance of constructors based on a set of criteria. The evaluation is done at certain stages during the actual construction of the project, and upon its completion;

WHEREAS, pursuant to Section 12, Annex E of the Revised Implementing Rules and Regulations (IRR) of RA 9184 or the Government Procurement Reform Act, all procuring entities and implementing government infrastructure projects are required to evaluate the performance of their contractors using the NEDA approved Constructors Performance Evaluation System (CPES) for the type of projects being implemented.

WHEREAS, Section 12, likewise requires all procuring entities to include in their Projects' Engineering and Administrative Overhead Cost, the budget for CPES implementation pursuant to NEDA Board Resolution No. 18 (s. 2002); to establish CPES Implementing Units in their respective offices/agencies/corporations; and to use the CPES ratings for the purposes specified therein;

WHEREAS, despite the above requirements, only 46 government entities and two (2) private sector associations have established their own CPES implementing units with a total of 1,461 accredited Constructors Performance Evaluators (CPEs) from government and private sectors;

WHEREAS, with the aggressive commitment of the government to implement infrastructure projects there is a need to further improve the performance of contractors in undertaking government construction projects;


WHEREAS, in the CIAP 74th Regular Meeting held on 27 March 2017, the Board recognizes the role of PDCB to help ensure efficiency, quality and safety in government projects through the promotion and implementation of CPES;

WHEREAS, in the said meeting, the CIAP Board proposed that PDCB adopt strategies to increase the number of CPES evaluators both from the government and the private sectors as well as provide measures to upgrade the professional and technical capabilities of all contractors.

NOW THEREFORE, for and in consideration of the foregoing premises and after due deliberations, the CIAP Board in its 74th Regular Meeting held on 27 March 2017, **RESOLVES** as it is hereby **RESOLVED**, to institutionalize the enforcement of the Constructors Performance Evaluation System (CPES) both in public and private projects. The Board **FURTHER RESOLVED** to instruct the Philippine Domestic Construction Board (PDCB) to submit proposal on how to improve the system to the CIAP Board for approval.


