**BAC Resolution Declaring Failure of Bidding for the Procurement for Partial
Renovation of the Administrative Building at the CMDF TC Cavite**

WHEREAS, the Construction Industry Authority of the Philippines (CIAP) advertised the Invitation to Bid for IB No. 2022-03-0008 for the **Partial Renovation of the Administrative Building at the CMDF TC Cavite** with an Approved Budget for the Contract of **Two Million Five Hundred Seventy-Four Thousand Two Hundred Eighteen Pesos and 90/100 (₱2,574,218.90)** in the PhilGEPS website, CIAP website, and at the conspicuous place within the office premises reserved for the procurement advertisements and announcements;

WHEREAS, one (1) bidder, Light Control Machine Contractors and Builders, purchased bid documents;

WHEREAS, during the scheduled submission and opening of bids on 28 March 2022, no bidder submitted their bids;

WHEREAS, Section 35, Rule X of the 2016 RIRR provides for the authority of the BAC to declare a failure of bidding when:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) **No bids are received;**
- b) All prospective bidders are declared ineligible
- c) All bids fail to comply with all the bid requirements or post-qualification, or x x x x (emphasis supplied)

WHEREAS, Section 35.3 of the same IRR indicates the steps and procedure that the BAC should take in case of failure of bidding: x x x

35.3 Based on the findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR. (underscored supplied)

NOW, THEREFORE, in light of the foregoing considerations, We, the members of the Construction Industry Authority of the Philippines – Bids and Awards Committee (CIAP-BAC) hereby **RESOLVE** as it is hereby **RESOLVED** to declare a failure of bidding for the **Partial Renovation of the Administrative Building at the CMDF TC Cavite** with an Approved Budget for the Contract of **Two Million Five Hundred Seventy-Four Thousand Two Hundred Eighteen Pesos and 90/100 (₱2,574,218.90)**. *Consequently*, the BAC shall conduct a re-bidding and re-advertisement and/or posting of the Project.
