BAC Resolution Recommending the Award of Contract to Nephila Web Technology, Inc. for the Procurement of CMDF Course-on-Demand Learning Platform

WHEREAS, the Construction Manpower Development Foundation (CMDF), one of the Implementing Boards of the Construction Industry Authority of the Philippines (CIAP) whose primary mandate is to enhance the competencies and capabilities of the human resources of the Construction Industry is in need of a Consultant/ Website Developer to help the CMDF develop an e-learning platform designed to help learners achieve the learning objectives of a seminar or training course without the need to physically attend sessions as required in a traditional set-up;

WHEREAS, the CIAP Bids and Awards Committee (CIAP-BAC) through its Secretariat advertised the Request for Quotation (RFQ) No. 2024-04-030 for the Procurement of CMDF Course-on-Demand Learning Platform with an Approved Budget of the Contract (ABC) of **Three Hundred Fifty Thousand Pesos (PhP 350,000.000)** in the PhilGEPS website, CIAP website, and at a conspicuous place within the office premises reserved for the procurement advertisements and announcement starting 16 April 2023 until 23 April 2024;

WHEREAS, in response to the posting of the RFQ, the Secretariat received one (1) bid offer from Nephila Web Technology, Inc. before the end of the prescribed deadline in the amount of **Three Hundred Forty-Three Thousand and Eighty Pesos (P 343,080.00)**;

WHEREAS, based on the evaluation of the Technical Working Group (TWG) using a Quality-Cost Based Evaluation, Nephila Web Technology, Inc. received a weighted score of **95.73** which is higher than the hurdle score of 80.00 points;

WHEREAS, upon careful examination by the TWG, it was found that the bid received from Nephila Web Technology, Inc. was found to be responsive and is within the ABC;

NOW, THEREFORE, in light of the foregoing considerations, We, the members of the Construction Industry Authority of the Philippines – Bids and Awards Committee (CIAP-BAC) hereby **RESOLVE** as it is hereby **RESOLVED**:


- a) to declare **NEPHILA WEB TECHNOLOGY, INC.** as the Single Calculated and Responsive Bidder (SCRB); and
