

BIDS AND AWARDS COMMITTEE RESOLUTION NO. 3 3 Series of 2024

BAC Resolution Declaring Netglobal Solutions, Inc. as the Lowest Calculated and Responsive Bid and Recommending the Award of Contract for the Procurement of 40 Units of Laptop with Office Suite (MS Office Home and Business 2021) and Antivirus with IB No. 2024-03-019

WHEREAS, Philippine Contractors Accreditation Board (the "End-User"), one of the Implementing Boards of the Construction Industry Authority of the Philippines (CIAP) wishes to procure forty (40) units of office laptops to be used by PCAB officials and staff in pursuit of the organization's full online digitization of PCAB services:

WHEREAS, the "End-User allotted an Approved Budget of the Contract amounting to Four Million Two Hundred Eighty Thousand Pesos (PhP 4,280,000.00), sourced from the CIAP-PCAB-DBM JMC No. 1 series of 2023 for the Procurement of 40 Units of Laptop with Office Suite (MS Office Home and Business 2021) and Antivirus (the "Project") with IB No. 2024-03-019:

WHEREAS, the CIAP Bids and Awards Committee (BAC), through its Secretariat advertised the Philippine Bidding for the Invitation to Bid (ITB) No. 2024-03-019 for the Procurement of 40 Units of Laptop with Office Suite (MS Office Home and Business 2021) and Antivirus in the PhilGEPS website, CIAP website and at a conspicuous place within the office premises reserved for the procurement advertisements and announcement starting on 08 March 2024 to 01 April 2024;

WHEREAS, the CIAP BAC issued Supplemental Bid Bulletin No. 1 on 22 March 2024 clarifying the questions and clarifications raised by the prospective bidders during the Pre-Bidding Conference and amending the deadline of submission and opening of bids from 01 April 2024 to 05 April 2024:

WHEREAS, before the prescribed deadline, the BAC Secretariat received bid offers from six (6) prospective bidders namely:

- a. Banitrade Enterprises.;
- b. Jonecotech Marketing Corp.:
- c. Quartz Business Products Corp.;
- d. Netglobal Solutions, Inc.;
- e. Xitrix Computer Corp.;
- f. Terabit Computer System Corp.;

WHEREAS, CIAP BAC issued a Notice of Postponement on 05 April 2024 rescheduling the Opening of Bids on 11 April 2024;

WHEREAS, during the bid opening and preliminary examination using a non-discretionary "pass/fail" criterion of the Technical and Financial Documents of the bidders, the following findings on their submitted documents were found:

WHEREAS, the BAC declared Banitrade Enterprises ineligible due to the submission of unsigned Statement of All Ongoing Government & Private Contracts Including Contracts Awarded But Not Yet Started;

WHEREAS, Banitrade Enterprises submitted a Motion for Reconsideration on 13 April 2024 requesting for the reversal of the BAC's decision but was later denied due to the submission of patently insufficient documents;

WHEREAS, the BAC through its Technical Working Group (TWG) conducted the detailed evaluation of the remaining five (5) eligible bidders' Technical and Financial Documents starting on 14 April 2024 to 16 April 2024;

WHEREAS, on 16 April 2024, the TWG submitted a comparative review of the Technical Requirements of the five (5) bidders who passed the preliminary evaluation with the following findings:

Quartz Business Products Corp.	Ineligible	Not compliant with the Technical Specifications. Offer for Memory is 16GB LPDDR5 instead of at least 16GB DDR5 (2x8GB)	
Netglobal Solutions, Inc.	Eligible	Compliant with Technical Specifications	
Xitrix Computer Corp.	Eligible	Compliant with Technical Specifications	
Terabit Computer System Corp	Eligible	Compliant with Technical Specifications	

WHEREAS, based on the recommendation of the TWG, the BAC declared Jonecotech Marketing Corp. and Quartz Business Products Corp. as ineligible; and Netglobal Solutions, Inc., Xitrix, Computer Corp., and Terabit Computer System Corp. as eligible;

WHEREAS, the CIAP-BAC through its Secretariat received the Motion for Reconsideration of Jonecotech Marketing Corp.on 23 April 2024 through electronic mail praying for the reversal of the decision of the BAC stating that the Graphics of the offered laptop based on the letter of configuration was indicated as Integrated Graphics but on the product brochure, the Graphics was highlighted as Intel Graphics;

WHEREAS, the Motion for Reconsideration of Jonecotech Marketing Corp. was denied by the CIAP BAC due to inconsistency of details on the submitted technical documents particularly the letter of configuration and the product brochure;

WHEREAS, having submitted the lowest bid and passed the detailed evaluation. Netglobal Solutions, Inc. was declared as the Lowest Calculated Bid and was subjected to post-qualification:

WHEREAS, the CIAP BAC instructed the TWG and Secretariat to proceed with the post-qualification process through BAC Resolution No. 25;

WHEREAS, A Notice of Lowest Calculated Bid and Post-qualification was issued to Netglobal Solutions, Inc. requesting for additional documents for the conduct of the postqualification process. Netglobal Solutions, Inc. submitted their post-qualification documents on 23 April 2024:

WHEREAS, the TWG submitted the post-qualification report dated 30 April 2024 recommending the award of the "Project" to Netglobal Solutions. Inc.:

NOW, THEREFORE, in light of the foregoing considerations. We, the members of the Construction Industry Authority of the Philippines - Bids and Awards Committee (CIAP-BAC) hereby RESOLVE as it is hereby RESOLVED:

- a) to declare Netglobal Solutions, Inc. as the Lowest Calculated and Responsive Bid (LCRB); and
- b) to recommend the award of the contract to Netglobal Solutions, Inc. in the amount of Two Million Nine Hundred Eighty-Three Thousand Two Hundred Pesos (PhP 2,983,200.00) for the Procurement of 40 Units of Laptop with Office Suite (MS Office Home and Business 2021) and Antivirus with IB No. 2024-03-019.
