CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of MAY 06, 2024 between the **CONSTRUCTION INDUSTRY AUTHORITY OF THE PHILIPPINES**, a national government agency created by virtue of Presidential Decree (PD) 1746 with office address at 369 Executive Building Center, Jupiter Street corner Makati Avenue Bel-Air, Makati City (hereinafter called "CIAP")

-and-

NETGLOBAL SOLUTIONS, INC., a private entity duly organized and existing under the laws of the Republic of the Philippines, with principal address at #59 West Capitol Drive cor. Stella Maris St., Brgy. Kapitolyo, Pasig City (hereinafter called the "Supplier").



WHEREAS, the "CIAP" invited Bids for certain goods and ancillary services, particularly 40 Units of Laptops with Office Suite (MS Office Home & Business 2021) and Antivirus and has accepted a Bid by the "Supplier" for the supply of those goods and services in the sum of **Two Million Nine Hundred Eighty-Three Thousand Two Hundred Pesos (PhP 2,983,200.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Two Million Nine Hundred Eighty-Three Thousand Two Hundred Pesos (PhP 2,983,200.00)** or such other sums as may be ascertained, **VICTOR V. FRANCISCO** agrees to deliver the 40 Units of Laptops with Office Suite (MS Office Home & Business 2021) and Antivirus in accordance with his/her/its Bid.
4. The CIAP agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
