	Is there a format for the Statement of Single Largest Completed Contract (SLCC), Omnibus Sworn Statement, and Bid Securing Declaration.	Bidders are required to use the GPPB prescribed forms for Infrastructure Projects.
	Is the Certificate of Site Inspection required during the bid submission?	No. The Site Inspection Certificate is not required to be submitted during the bid submission.
	Does CIAP require a format for the Schedule of Requirements?	No. Bidders may use the format they deem appropriate for this infrastructure project.

	May we request a Technical Specification where we can indicate the Comply or Not Comply as well as specifications of the item to be bid?	Statement of compliance is not required. All submissions shall be subject to detailed evaluation and/or post-qualification of the submitted documents/requirements.
	Which quantity will prevail between the proposed plan and bill of quantities?	The number of units indicated in the Bill of Quantities will be the basis of the bid.
	What was the basis of the quantity indicated in the Bill of Quantities?	The quantity was based on the existing and approved budget for this project.
	What are the specific areas where the airconditioning units will be installed?	Refer to Amendment/ Final Requirement/ Clarification No. 3 of Supplemental Bid Bulletin No. 1.
	May the bid submission be extended?	The bid submission is extended until 6 December 2024 at 12:00 NN.

Amendments/inclusions/clarifications made herein shall be considered an integral part of the said Bidding Document.
