## Checking of Boundaries of Lot 5847-B-7

Conduct a detailed boundary check of Lot 5847-B-7 to ensure it is properly demarcated and complies with adjacent property lines.

# Preparation of Sketch/Location Plan


Using the data collected from the field survey, the Geodetic Engineer will create a detailed sketch or location plan. This plan will typically include:

- Clear boundary lines for each lot (e.g., Lot 5747-C and Lot 5847-B-7).
- · Measurement of dimensions for each boundary segment.
- · Marked areas indicating any observed encroachments.
- Total area of each lot, and area calculations for any encroached sections.

# **Preparation of Geodetic Engineer Survey Report (Certification)**

Provide two (2) sets of certified reports signed and sealed by the Geodetic Engineer. These will include all pertinent details of the verification survey, boundary data, and certification of survey results.
